

SWEEPSTAKES RULES

NATIONAL ASSOCIATION FOR GUN RIGHTS "2021 MERRY CHRISTMAS" GIVEAWAY OFFICIAL RULES. NO PURCHASE NECESSARY TO ENTER OR WIN. OFFERED ONLY TO CITIZENS OR LEGAL RESIDENTS OF THE UNITED STATES AGED 21 YEARS OR OLDER.

1. ELIGIBILITY: Open to United States citizens or legal residents who are 21 years of age or older. Employees, Officers and Directors of the National Association for Gun Rights (the "Sponsor"), its subsidiaries, affiliates, advertising and promotion agencies (collectively, the "Sponsor and its agents") and immediate family members (spouses and siblings, children and parents and their spouses, regardless of where they live) or members of the same households (whether related or not) of such individuals are not eligible. No purchase is necessary to enter the Sweepstakes. Entries to the "2021 Merry Christmas" Giveaway will automatically be entered into the "1959 Daimler Ferret MK 2/3 Scout Car and Browning 1919A4 semi-auto belt-fed firearm in 7.62mm NATO" Giveaway ("Ferret Sweepstakes").
